# **TAX REPORT 2022**

## Basis of presentation

The disclosures and data contained in this document are reported on the basis of the Country-by-Country Report ("CbCR") prepared and filed by Saipem SpA as the Ultimate Parent Company of the Saipem Group.

Under BEPS (Base Erosion and Profit Shifting) Action 13, released by the OECD (Organisation for Economic Co-operation and Development), large multinational enterprises (MNEs with consolidated group revenue of €750 million or more) are required to prepare a country-by-country report with aggregate data on the global allocation of income, profit, taxes paid and economic activity among tax jurisdictions in which it operates. This CbCR report is shared with tax administrations in these jurisdictions for use in high level transfer pricing and BEPS risk assessments.

Saipem SpA submits the CbCR to the Italian Revenue Agency ("Agenzia delle Entrate") for each fiscal year in accordance with Law No. 208/2015 as enacted by the Ministry of Economy and Finance Decree 23/2017. The submission of Saipem SpA's CbCR complies with the reporting template approved by the OECD. Some amendments have been provided for better disclosure on the effective tax rate of jurisdictions.

# Reporting MNE and constituent entities

The list of the constituent entities encompasses all the companies which are directly or indirectly controlled by Saipem SpA.

#### Treatment of Permanent Establishments (PE)

The data for branches and PEs of the constituent entities are reported by reference to the tax jurisdiction in which such branches and PEs are located and operating. Therefore, with reference to the jurisdiction of tax residence of the constituent entities, the relative data exclude those related to the respective branches and PEs.

### Source of data

The source of the data presented in this report, which have been aggregated by tax jurisdiction, are the separate statutory financial statements of each constituent entity. Differences between local GAAP and the IFRS used to prepare the Group's consolidated financial statements are deemed to have a negligible impact on the financial figures disclosed in this report.

#### Reporting period

The reporting period is the fiscal year 2021 of the parent company Saipem SpA, which coincides with the calendar year.

#### Structure and content

This report comprises a statement for each of the tax jurisdictions where the Saipem Group operated in the period under observation. The amounts in each tax-jurisdiction statement have been obtained by aggregating amounts sourced from the local financial statements of all the constituent entities that are tax residents in such jurisdiction or operate there through a branch or a PE. In the event that the local financial statements of a branch or a PE were not available, the data were taken from the accounting records of the company to which the PE belongs, separating them from the data relating to the head office or other branches of PEs of the same company.

#### Content of each tax jurisdiction statement

The following aggregate data are given for each tax jurisdiction:

#### List of all the constituent entities of the Saipem Group

The report lists the names of all the legal entities resident or operating through a PE in the relevant tax jurisdiction.

#### Primary business activity

The primary business activity is indicated for each constituent entity operating in the relevant tax jurisdiction.

#### Total revenues

These are the revenues generated in the period under observation by all the Group constituent entities resident in the relevant tax jurisdiction or operating there through a branch or a PE. The breakdown of the revenues generated by transactions with unrelated and related parties is also provided, even within the same tax jurisdiction. Revenues include all positive income items, e.g. revenues from sales of products and services, royalties from industrial patents, interest income, gains from the sale of plant, property and equipment, intangible assets and equity investments and unrealised profits (such as the fair value of derivatives held for purposes other than hedging). Inter-company dividends are excluded from revenues. Gains recognised in comprehensive income are also excluded.

#### Profit (loss) before income tax

This is the sum of the pre-tax profits and losses recorded in the period under observation by all constituent entities resident in the relevant tax jurisdiction or operating there through a branch or a PE.

#### Income taxes paid (on a cash basis)

These data refer to the income taxes paid during the period under observation by all the constituent entities resident or operating through a PE in the relevant tax jurisdiction. Taxes are reported on a cash basis and include taxes paid by the constituent entities to the residence tax jurisdictions and to all other tax jurisdictions. In this respect, they also include withholding taxes paid by other Group entities on payments to the constituent entities in the jurisdiction for the provision of intercompany services.

#### Current income taxes accrued

These data refer to the accrued current tax expenses recorded on taxable profits or current tax credit in case of current losses, recorded by all the constituent entities resident or operating through a branch or a PE in the relevant tax jurisdiction. Deferred tax assets or liabilities, or provisions for uncertain tax liabilities are not included.

#### Reversal of DTA (utilisation of fiscal losses)

These data refer to the amounts of Deferred Tax Asset (either previously recognised or not in the relevant financial statements) reversed in the period under observation due to the utilisation of tax losses. These data are provided for the jurisdictions where there was a significant difference between the standard tax rate and the effective tax rate only.

#### Number of employees

The number of employees represents the average number of employees of all the constituent entities resident or operating through a branch or a PE in the relevant tax jurisdiction.

#### Reporting currency

The reporting currency is the euro. Amounts are stated in millions of euros. Amounts reported in other currencies have been converted into euro at the average exchange rate for the period under observation.
