# Storage limitation

Personal and identification data (including name, surname, date and place of birth, tax code, residential address, telephone, e-mail, identification document) Exercise of the right of withdrawal pursuant to Articles 2437 et seq. of the Italian Civil Code by Saipem's Savings
Shareholders who did not participate in the approval of the Special Shareholders' Meeting resolution held on May,8, 2025 (i.e. absent, abstained or voting against).

Execution of a legal obligation to which the Owner is subject.

10 years from to exercise of the right of withdrawal, except for the need to extend the retention period for the purposes of judicial protection of the Controller, until the deadline for any legal remedy has been exhausted.

If necessary, to assert or defend a right of the Company in court or in arbitration and conciliation procedures.

Legitimate interest of the Controller consisting in the need to protect their rights in the competent bodies For the entire duration of the dispute, until the deadline for any legal remedy has been exhausted.

Once the storage deadlines indicated above have passed, the data will be destroyed or made anonymous, in line with the technical procedures for deletion and backup.



# Methods of processing and provision of data and consequences of failure to provide them

Processing will be carried out in digital form, with methods and tools aimed at ensuring maximum security and confidentiality, by subjects specifically appointed to do so.

Please note that all the personal data provided by you will be processed in accordance with current legislation on privacy. Therefore, the Company undertakes to process said data in accordance with the principles of fairness,

lawfulness and transparency, in compliance with the purposes set out below, collecting said data only for specified and necessary purpose. Only authorised and properly trained personnel will be allowed the use of said data in order to guarantee the necessary confidentiality of the information provided.

The provision of the personal data indicated above is necessary to achieve the listed purposes. Failure to provide data will make it impossible to carry out the processing.

The collection of personal data takes place directly through the interested party or by means of a delegation granted to the possible delegate.



## Recipients and transfer of data

- Judicial authorities, as well as those subjects to whom communication is required by law or by contract. These subjects will process the data in their capacity as independent Data Controllers.

## Rights of the interested party

Data Subjects have the right to ask the Controller for access to their personal data, rectification, deletion or portability of their personal data, integration of incomplete personal data, limitation of processing in the cases provided for by art. 18 GDPR. In addition, where applicable, Data Subjects may revoke their consent at any time.
