IA.2.1.3), it is also communicated that, with reference to the distribution of the dividend, if any, based on the results of the 2025 financial year, the ex-dividend date is currently scheduled for the month of May 2026. that the prerequisites for the distribution of dividends relating to financial year 2025 and future financial years exist.
